- 1.) REMOVE APPROX. 20,422 SQ. FT. (ALL DRIVING LANES) TO A DEPTH OF TWO (2) INCHES. DISPOSE OF ALL SPOILS.
 - 2.) WATER MIX, GRADE AND COMPACT EXISTING BASE MATERIAL. SO AS WATER DRAINS TO EXISTING DRY WELLS.
 - 3.) APPLY TWO (2) INCHES OF HOT 1/2" 5.5% ASPHALT TO APPROX. 20,422 SQ. FT. (ALL DRIVING LANES). ROLL AND COMPACT.
 - 4.) CRACKFILL = POWER CLEAN ALL CRACKS 1/4" OR WIDER USING COMPRESSED AIR. APPLY A HOT RUBBERIZED CRACK SEALING MATERIAL; APPROX. 2,000 LINEAR FEET.
 - 5.) SLURRY SEAL: CLEAN APPROX. 1,795 SQ. YDS. OF ASPHALT; FREE OF DIRT AND DEBRIS. APPLY A TYPE II CATIONIC ASPHALT SLURRY SEAL AT A RATE OF 18-18 POUNDS PER SQUARE YARD, 15-16% OIL CONTENT. COMPACT USING A STEEL WHEEL ROLLER. (ALL PARKING AREAS) OIL TO BE POLYMER MODIFIED.
 - 6.) RESTRIPE ALL PARKING LANES AND REPAINT ALL EXISTING RED CURB.
 - 7.) MOVE - IN - JOB TO BE COMPLETED IN TWO (2) MOVE - INS.
 - 8.) TAXES - ALL PRICES QUOTED ARE SUBJECT TO ALL STATE AND LOCAL TAXES AND THESE AMOUNTS SHOULD BE ADDED TO QUOTED PRICES; OTHERWISE, A SALES TAX EXEMPTION NUMBER MUST BE FURNISHED.
